

## Inspection Summary Statements

The Accreditation Scheme assesses the standards of management, resources and premises, teaching, welfare, and safeguarding under 18s and accredits organisations which meet the overall standard in each area inspected. Centres inspected between 2021 and 2023 had the option to undertake a compliance-only inspection.
